AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING July 1, 2019__ AND ENDING ON __June 30, 2020___

WHEREAS, the Ela Area Public Library District (the "Library") is an Illinois Public Library District organized and operating pursuant to the Public Library District Act of 1991, 75 ILCS 16/1-1, et seq. (the "Code");

WHEREAS, the Library adopted Ordinance __19-09-02__, its Annual Budget and Appropriation Ordinance for the fiscal year beginning __July 1, 2019___ and ending on __June 30, 2020 (the "Appropriation");

WHEREAS, Section 30-85 of the Code states the Library Board shall comply with the Illinois Municipal Budget Law; and

WHEREAS, Section 3 of the Illinois Municipal Budget Law states in pertinent part that the governing body of the Library may from time to time make transfers between the various items in any fund in such appropriation ordinance not exceeding in the aggregate ten per cent of the total amount appropriated in such fund by such ordinance;

WHEREAS, the Board finds that the appropriations for four line items: EQUIPMENT MAINTENANCE-ALL OFFICE, LEGAL – ATTORNEY/PUBLICATION, OTHER - and PRINTING, in the General Fund, and Equipment Maintenance, in the Site & Building Fund, as described in the Appropriation are insufficient for the anticipated needs for such line items for the current fiscal year;

WHEREAS, the Board finds that a transfer of the excess appropriation from the SALARY line item in the General Fund to the herein identified lines in the same fund shall (a) provide

sufficient appropriation for the current fiscal year, and (b) not result in any deficit of appropriations in the General Fund for the current fiscal year:

EQUIPMENT MAINTENANCE-ALL OFFICE	\$8800
LEGAL - ATTORNEY/PUBLICATION	\$7700
PRINTING	\$4200

WHEREAS, the Board finds that a transfer of the excess appropriation from the GROUNDS MAINTENANCE line item in the Site & Building Fund to the herein identified lines in the same fund shall (a) provide sufficient appropriation for the current fiscal year, and (b) not result in any deficit of appropriations in the Site & Building Fund for the current fiscal year:

Site & Building: Equipment Maintenance	\$600	

NOW, THEREFORE, BE IT ORDAINED by the Board of Library Trustees of the Ela Area Public Library District, Lake County, Illinois as follows:
