ORDINANCE NO. 20-11-01

**AN ORDINANCE LEVYING TAXES FOR LIBRARY PURPOSES
FOR THE FISCAL YEAR 2021/2022 FOR THE ELA AREA PUBLIC LIBRARY DISTRICT,
LAKE COUNTY, ILLINOIS**

WHEREAS, on September 15, 2020, the Board of Library Trustees adopted the District's annual budget and appropriation ordinance (the "Budget Ordinance"), a certified copy of which was published once and is hereby incorporated by reference;

WHEREAS, the Board of Library Trustees verifies that the levy herein described is for not more than the total amount of the appropriation described in the Budget Ordinance;

WHEREAS, the Board of Library Trustees approved Ordinance #20-06-01, a 0.02% levy for site and building maintenance and repair on June 16, 2020, which was authorized upon the expiration of the deadline for a "Backdoor referendum" 30 days later;

WHEREAS, the Board of Library Trustees, not less than twenty (20) days preceding the date of this Ordinance, established an estimate of levy and ascertained that the proposed levy was 3.02% greater than the preceding year's extension and therefore a public hearing in compliance with the Truth in Taxation Act was not necessary;

WHEREAS, this proposed levy increase of 3.02% includes the 0.02% site and building levy;

WHEREAS, the Board of Library Trustees reevaluated the proposed levy increase of 3.02% determining to levy an increase of .09% which includes the 0.02% site and building levy;

BE IT ORDAINED by the Board of Library Trustees of the Ela Area Public Library District, Lake County, Illinois:

Section 1. That taxes in the amount of SIX MILLION TWO HUNDRED EIGHT THOUSAND THREE HUNDRED SEVENTEEN DOLLARS (\$6,208,317.00) be and hereby is levied upon all taxable property within the corporate limits of this District, said tax be levied to defray the expenses and liabilities of this District for the fiscal year beginning July 1, 2021 and ending June 30, 2022, for the specific objects and purposes indicated as follows:

Section 2. Pursuant to Section 40-50 of the Public Library District Act, the library board may transfer to the special reserve fund the unexpended balances of the proceeds received annually from annual public library taxes not in excess of statutory limits if (i) the board has resolved to develop and adopt a capital plan or plans and (ii) the board provides in the annual appropriation ordinance for accumulation of those unexpended balances. The unexpended balance of any item or items levied in and by this ordinance may be expended in making up any deficit of any item or items in the same general appropriation and levy made by this ordinance.

Section 3. The Secretary of this board shall file, on or before the last Tuesday in December, a certified copy of this levy ordinance with the county clerk of each county affected by this levy; and the Secretary of this board shall also file, on or before the last Tuesday in December, certified copies of this ordinance and the budget and appropriation ordinance with the library or libraries operated by this District, and make said ordinances available for public inspection at all times.

Section 4. Upon filing said certified copy hereof with such county clerk, the rate percent shall be ascertained and the tax extended as provided by law against taxable property in this District, and the tax so levied and assessed shall be collected and enforced in the same manner and by the same officers as the general taxes in this district and county, and shall be paid over to the Treasurer of this board by the officers collecting the same.

Section 5. This ordinance is passed pursuant to statutory authority, including the Illinois Public Library District Act, the Illinois Municipal Budget Law, the Illinois Revenue Code, and other statutes thereunto appertaining.

Section 6. This ordinance shall be in full force and effect from and after its passage and approval in accordance with law.






