**AN ORDINANCE AMENDING THE
APPROPRIATION ORDINANCE
FOR THE FISCAL YEAR BEGINNING
July 1, 2015 AND ENDING ON _June 30, 2016_**

WHEREAS, the Ela Area Public Library District (the “Library ”) is an Illinois Public Library District organized and operating pursuant to the Public Library District Act of 1991, 75 ILCS 16/1-1, et seq. (the “Code”);

WHEREAS, the Library adopted Ordinance __15-09-02__, its Annual Budget and Appropriation Ordinance for the fiscal year beginning __July 1, 2015__ and ending on __June 30, 2016 (the “Appropriation”);

WHEREAS, Section 30-85 of the Code states the Library Board shall comply with the Illinois Municipal Budget Law; and

WHEREAS, Section 3 of the Illinois Municipal Budget Law states in pertinent part that the governing body of the Library may from time to time make transfers between the various items in any fund in such appropriation ordinance not exceeding in the aggregate ten per cent of the total amount appropriated in such fund by such ordinance;

WHEREAS, the Board finds that the appropriations for six line items - Electronic Information, Service & Technology Pilots, Postage, Travel, Furniture/Equipment, and Benefits – Health Insurance in the General Fund described in the Appropriation are insufficient for the anticipated needs for such line items for the current fiscal year;

WHEREAS, the Board finds that a transfer of the excess appropriation from the Programs – Adult line item in the General Fund to the herein identified lines in the same fund shall (a) provide sufficient appropriation for the current fiscal year, and (b) not result in any deficit of appropriations in the General Fund for the current fiscal year:

Travel	\$4,656.40
Furniture/Equipment	\$2,707.57
Benefits: Health Insurance	\$107.08

WHEREAS, the Board finds that the appropriations for Grounds Maintenance in the Site & Building Fund described in the Appropriation are insufficient for the anticipated needs for this line items for the current fiscal year;

WHEREAS, the Board finds that a transfer of the excess appropriation from HVAC Repair and Maintenance line item in the Site & Building Fund to the Grounds Maintenance line in the same fund shall (a) provide sufficient appropriation for the current fiscal year, and (b) not result in any deficit of appropriations in the Site & Building Fund for the current fiscal year:

NOW, THEREFORE, BE IT ORDAINED by the Board of Library Trustees of the Ela Area Public Library District, Lake County, Illinois as follows:

SECTION ONE: The Board finds the foregoing recitals to be true and correct and hereby incorporate them as its legislative findings as though fully set forth herein.

SECTION TWO: The Appropriation for current fiscal year shall be amended by:

A) Transferring \$_12,722.74_____ from the appropriation for __Programs-Adult__ purposes to the appropriation for __Electronic Information_____ purposes in the General Fund.

B) Transferring \$_52.44_____ from the appropriation for __Programs-Adult_____ purposes to the appropriation for __ Service & Technology Pilots_____ purposes in the General Fund.

C) Transferring \$_2,774.92_____ from the appropriation for __Programs-Adult__ purposes to the appropriation for __ Postage_____ purposes in the General Fund.

D) Transferring \$_4,656.40_____ from the appropriation for __Programs-Adult_____ purposes to the appropriation for __ Travel_____ purposes in the General Fund.

E) Transferring \$_2,707.57_____ from the appropriation for __Programs-Adult__ purposes to the appropriation for __ Furniture/Equipment_____ purposes in the General Fund.

F) Transferring \$_107.08_____ from the appropriation for __Programs-Adult_____ purposes to the appropriation for __ Benefits: Health Insurance_____ purposes in the General Fund.

G) Transferring \$_6,517.70_____ from the appropriation for _HVAC Repair and Maintenance____ purposes to the appropriation for __ Grounds Maintenance__ purposes in the Site & Building Fund.

SECTION THREE: Subject to this Ordinance being approved by a majority of the Board of Library Trustees, the Board delegates authority to the Executive Director, Treasurer and the Library's auditors to take all necessary and appropriate actions to implement the transfers herein described, record such changes in the Library's books and records in the manner provided by law and ratifies all actions and expenditures heretofore taken which are consistent with the purpose of this Ordinance.

SECTION FOUR: Severability. The various provisions for this Ordinance are to be considered severable and if any part or portion of this Ordinance be held invalid by any Court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this Ordinance.

SECTION FIVE: Effective Date. This Ordinance shall be in full force and effect upon its passage and approval.
